Award Application Guidelines

Every year the Brainerd Lakes Chamber of Commerce recognizes an outstanding business for its entrepreneurial spirit and accomplishments. **The Business Excellence Award** shines the spotlight on one Brainerd Lakes Chamber member business that exemplifies the following attributes:

LEADERSHIP

- Manages change or adversity to achieve exceptional business growth
- Maintains outstanding customer service, sound management and ethical business practices
- Provides industry leadership with its products and services

INNOVATION

- Demonstrates a willingness to take risks
- Introduces creative products or services to the marketplace
- Strives to adapt and improve based on competition and market trends

EMPLOYEE INVESTMENT

- Generates outstanding results through employee engagement and teamwork
- Invests in employees through training, benefits and advancement opportunities
- Maintains a dynamic culture that attracts and retains a high-quality workforce

COMMUNITY SERVICE

- Provides community leadership that benefits the Brainerd Lakes Area
- Offers generous support and volunteerism to community organizations
- Advances economic growth by supporting other local businesses

Award Eligibility Criteria

To be eligible for the Business Excellence Award, businesses must be a Chamber member and be physically located in the Brainerd Lakes Area and have more than 25 employees. Potential applicants are encouraged to verify eligibility with the Chamber before completing the award application.

Ineligible entities generally include individual leaders or employees; charities and community organizations; schools and colleges; government units or agencies; religious organizations, associations, and any other entity not deemed by the Chamber Board of Directors to fit the broadly accepted definition of a business.

Application & Judging Process

Businesses that meet the award eligibility criteria are encouraged to apply directly. Brief nominations are also accepted, which prompts Chamber staff to contact the nominee and encourage them to submit the full application.

Applications are due by 4:30 p.m. on May 31, 2022, addressing the items on the form that follows. Appointed by the Chamber's Board of Directors and led by the Business Awards Chair, an independent panel of judges will score applicants and make the final award selection. All applications are confidential. If not chosen to receive the Business Excellence Award, applicants are encouraged to update information and resubmit the following year.

The award recipient will be contacted by mid-July and will receive the following:

- Recognition before, during, and after the Chamber's Celebration of Excellence on November 17, 2022
- Complimentary event tickets for a reserved table of eight
- A high-quality keepsake award presented by the award sponsor, Hy-Tec Construction
